Environmental Ed- students created 3-D biome dioramas and did presentations of them. They all did a nice job. We did a Bioblitz with Mike Joint and Mary Shedd, took groups outdoors to identify trees, plants, animals, fungi on our property. Also did two community service days (highway pickup, potters field, school library, greenhouse work, assembled new pianos, made candles to sell at craft show). Choir sang at bingo last month.

Karin- Heidi Favet, community mental health worker, gave a presentation to staff and will help connect staff to area agencies to help our students. Staff would like to sponsor a mental health resource day for students and the community with her help.

Frank- Staff is having discussion on mental health and other needs of our students. School laundry, school clothes closet, Ely Stop and Shop will offer vouchers to purchase clothing.

Karin reported on beginning of year testing. Students have all be placed into ability groups. NWEA testing is completed, including the new students, ADSIS underway for students below grade level for math and/or language arts.
