Takes 6 students for overnight sailing/environmental ed program

TEDA grant for entrance signs, highway signs
Received a grant for \$1,500
Quotes for shorter directional signs for Hwy 135 and by civic center, larger sign for at entrance road
\$2,800 for large sign

\$1,500 for small sign (each)

Motion to purchase two new larger signs for school entrance road at cost of \$2,800, will wait on ordering smaller signs until get authorization for sign placement. Have grant to cover \$1,500 of the cost. Give Frank the authority to spend up to \$3,000 additional for the two smaller direction signs.

Paycheck Protection Program grant
Received first round loan for approx. \$90,000
We have almost used up that money in payroll and lease expenses, so eligible for forgiveness.

Frank- PPP-2 opportunity, seeing if the school is eligible, deadline is end of March

Motion to approve applying for PPP-round two, if school meets financial eligibility guidelines, by Marit, second by Karin- all yes

We will be using this money to serve our students and support our staff. Congress has made these one-time loans available to nonprofits like ours. Unlike school districts, public charter schools receive no local property taxes that can help offset state cuts. We are grateful for this one-time support and are using it to pay our staff and support our students during uncertain time.

## **School Updates**

Getting new anti-bullying software ready (was free to school)

Did apply for a Cares grant from SLC- did not receive, didn't award to non-profits
Have applied for more covid-related grants for PPP, safety materials needed
May be up to \$50,000 in round two, may be more available in round three
Funding can be used for furniture, structural pieces, and technology
Such as new desks and chairs, lockers, building renovations, possibly a vehicle
Last year we did approve purchasing new computers/chromebooks (still on backorder). They are finally available, cost is lower than we expected, about \$20,000
Possibly some more funding coming from state and for summer programming, will discuss with staff

Osprey Wilds site visit on April 30 via Zoom

At this point in time, indoor graduations are permitted with social distancing between families or groups of 6, to allow for contact tracing if needed, capacity based building occupancy, encourage outdoor ceremonies if possible, masks are required

We will plan graduation in house (10 seniors)

Did ASVFAB testing today, MCAs and NWEA coming in April and May

One new 7<sup>th</sup> grader starting this week, two add'l students may be starting soon
